GENERAL RULES:

- Shooting order will be by random number generator. However no gun will be permitted to be used more than once per day. The shooting order will be adjusted as necessary for shooters sharing rifles. If two shooters make it into the finals using the same gun, they will have to choose which of them shoots during the finals.
- Ranges and angles to targets will be unknown until the shooters briefing, but will not exceed 10 degrees vertical. This is not mountain shooting.
- This is a team competition (shooter and up to two spotters/wind coaches).
- Any rifle under 50 pounds is allowed however rifles over .50 caliber will require prior approval. Rifle weight is determined by its "Ready to fire" configuration.
- The weight of all other shooting equipment is limited to 25 pounds.
- The rifle has to be supported in the front by a folding or collapsible bipod. Nothing can be added to the bipod for additional support once the rifle is on the ground. Examples of this are sandbags and stakes. The shooter must make all adjustments to his/her rifle system once the string of fire begins. Examples, adjusting height of bipod/rifle and adjusting the scope. Once the string of fire begins, any forgotten equipment the shooter requires must be obtained by the shooter.
- The rear of the rifle may be supported by a bag of any kind, monopod or the shooter but not a rest.
- Any rifle optics and spotting scope system are allowed. No team may directly view the video feed from the target cameras during their record string or receive any signal from outside the firing point.
- No weapon alibis. After a rifle has a second malfunction of the same type, any additional malfunctions disqualify the shooter and the rifle must be removed from the line. Once a malfunction has been detected, permission can be given by the range officials for the shooter to have additional help in clearing it.
- Spotters/ wind coaches can double for various shooters if they are willing to.
- Spectators are not permitted to communicate with the team currently shooting in any way.

- No practicing is allowed on the course prior to the competition.
- There will be a shooting position “box” for shooter and their spotters. Spectators must stay far enough away that they will not disturb the team currently shooting.
- Our plan is to have an electronic target placed in conjunction with the first steel target. If this happens, windage and elevation correction calls will be relayed to the shooter for any detected shots. Should there be a target failure, calls will be made by match officials using video relays and spotting scopes on the steel target. After the first target, the team is on it’s own for sighting and adjusting impacts.
- Once shooters have finished their shooting string, they must quickly remove their equipment to allow the next team to set up. Both the previous and next team will handle weapons UNLOADED and with a CHAMBER FLAG or other visual indicator of an empty chamber.
- The “Failure to do right” rule is in effect for this competition. The match director can disqualify any competitor for attempting to stretch the letter of the rules or gaming to gain an unfair advantage which is against the spirit of the competition.

COURSE OF FIRE:

Teams will be given a map of the target locations and ranges as determined by laser range finder. Competitors are welcome to use their own range finding equipment if they choose to.

Day 1&2

Target ranges will be approximately 1400 to 2000 yards. Shooters will have 5 minutes to set up and 9 minutes to complete their four target string. Five shots will be taken on target one and three shots each on targets 2-4. A failure to hit any target with the allotted number of rounds will mean elimination. The top ten scoring teams will advance to the finals on day three.

Day 3:

Target ranges will be approximately 2500 to 3500 yards. The top ten scoring teams will proceed to the finals. Shooters will have 5 minutes to set up and 10 minutes to complete their three target string. Time allowing, shooters will fire a total of 15 shots. The shooter must hit the target in order to advance to the next and fire a minimum of 5 shots before proceeding to the next target. Hits after the fifth shot will allow progression to the next target but will award no points.

SCORING:

Scoring for day 1&2 will be based on shot order times range plus the remaining time in seconds. For target one, the multipliers are 5,4,3,2,1. For subsequent targets the multipliers are 3,2,1. Multipliers for day 3 are 5,4,3,2,1,0 on targets 1-3. So a 2nd round hit on the first target with a range of 1454 yards and subsequent misses from there on with 5 minutes remaining would yield a score of 6,116 (1454x4+300)

Remember to bring your 50 and compete in the FCSA World Championships starting June 30th!

FIFTY CALIBER SHOOTERS ASSOCIATION WAIVER AND RELEASE OF LIABILITY

The Fifty Caliber Shooters Association ("FCSA") is a nonprofit organization dedicated to the advancement of the sporting use of the .50 BMG cartridges. I _____ the undersigned person, request to voluntarily participate in FCSA sponsored activities and competitions specifically, the competition dated: _____ (hereinafter referred to as "Competition"). In consideration of the permission granted by FCSA to participate in this Competition, I, for myself, my personal representatives, heirs, next of kin, spouse, and assigns, DO HEREBY:

1. Release, discharge and covenant not to sue FCSA's officers, agents, staff, trustees, operators, personnel, property owners, attorneys, and employees (all hereinafter collectively referred to as the "Releasees") from any and all claims, liabilities, or ordinary negligence of Releasees or any other participant which causes the undersigned injury, death, damages, or property damage. I hereby covenant to hold Releasees harmless and indemnify Releasees for any claims, actions, suits, complaints, procedures, costs, expenses, judgments, damages and liabilities or expense Releasees may incur arising out of, or connected with my activities or participation in the competition or club activity, or presence in the range.
2. Understand that my entry into the Competition and/or participation therein, and my entry upon any premises where said Competition is held, that there is a DANGER AND RISK OF INJURY OR DEATH. In addition, I understand that the present condition and activities of the Competition may change and may become more hazardous and dangerous and that there is INHERENT DANGER in said Competition, which I appreciate and voluntarily assume because I choose to do so. I have observed gun competitions of this type that I seek to participate in, and I have and/or will have my own equipment to participate in said activity, including ammunition and have inspected said equipment and ammunition and the area of competition. I further know that other participants in the Competition or activity pose a danger to me, nevertheless I VOLUNTARILY ELECT TO ACCEPT RISKS connected with my entry into and participation in the Competition.
3. Acknowledge that I am aware of generally accepted all gun safety rules and regulations and have been advised of the rules of the Competition and my responsibilities during the match and have complied with each said rule, regulation, and responsibility. If I have failed so to do, or if I fail so to do I ASSUME RISK for myself and assume all liability to others for such failure(s) and I hereby RELEASE all Releasees for any failure(s) in inspecting my equipment or others failures to so do. No oral representations, statements, or inducements, apart from this written statement have been made to me to sign this agreement. If any portion of this agreement is held invalid, it is agreed that the balance thereof shall continue in full legal force and affect.
4. Agree that this agreement shall apply to any accident, injury, incident or death occurring at the above-mentioned competition or activity.
5. Agree that I am fully aware that I am attending a LIVE FIRE Competition and therefore understand the risk and inherent danger of the possibility of injury and/or death.
6. Understand that if any legal action is taken or brought under this agreement, the prevailing party shall be entitled to recover from the other party, reasonable attorney fees whether or not a suit is filed.
7. Agree that this agreement shall be governed by and construed in accordance with the laws of the state of Utah or any other state where it is signed.

I HAVE CAREFULLY READ THIS DOCUMENT AND FULLY UNDERSTAND ITS CONTENTS. I UNDERSTAND IT IS A RELEASE OF ALL CLAIMS. I UNDERSTAND AND ASSUME ALL RISK INHERENT IN THE COMPETITION. I VOLUNTARILY SIGN MY NAME EVIDENCING MY ACCEPTANCE OF THE ABOVE PROVISIONS.
